17. **The school should not start Class XI/XII without written approval of the Board.** The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
18. The affiliation Code Number allotted to your school is **1720014**. This may please be noted and quoted on every correspondence with the Board.
19. It will continue to pay Annual Fee of Rs. 3,000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt.
